

Additional Information:

- a. Receipt of scholarship assistance after the first year is contingent upon the recipient's annual reapplication for such assistance as well as on a scholastic record of demonstrated good standing. Yearly scholarship assistance is not guaranteed.
- b. Scholarship recipients may attend any medical, osteopathic or dental school of their choice, accredited by the Association of American Medical Colleges, the American Osteopathic Association or the Council on Dental Education of the American Dental Association. Recipients may establish practices in communities of their choice.
- c. Candidates will be notified of their selection or nonselection for scholarships on or about June 15. Successful candidates will have their scholarship awards forwarded directly to them by the PNC Bank, the Trustee under Miss Lapsley's will.
- d. The decision of the JFK-Muhlenberg Campus Board of Directors with respect to eligibility for an award of scholarship is final.

The Lapsley Scholarship



Scholarships are awarded yearly by the JFK-Muhlenberg Campus Board of Directors to provide annual financial aid to one or more needy candidates matriculating in a program for a career degree in the study of medicine, osteopathy or dentistry.



Howard G. Lapsley

A resident of Plainfield, New Jersey, Howard G. Lapsley was dedicated to improving the quality of life for all mankind. He was an inventor, electrical engineer, volunteer and member of the adjunct Medical Staff of Muhlenberg from 1957 to 1967.

He is most noted for inventing multiple oxygenating devices for the fast care of mass disaster victims.

As a memorial to her brother, Josephine Lapsley provided for the establishment of the Howard G. Lapsley Memorial Scholarship.

The Selection Process

Selection of Scholarship recipients is made by the JFK – Muhlenberg Campus Board of Directors with the program being administered by the Board, which reviews applications, conducts personal interviews with the most promising candidates if necessary and makes final selections.

The scope of the scholarship is not limited to tuition, but may also include (at the discretion of the Board of Directors) such fees as those for board, lodging, travel, meals, books and supplies required pursuant to the core curriculum.

Eligibility

The goal of the fund is to assist eligible candidates with financial requirements for the study of medicine, osteopathy, or dentistry.

Eligible candidates must satisfy the following criteria:

- a. Candidates must have been raised (attended or eligible to attend elementary or secondary school) in one of these communities:

Union County

Berkeley Heights/ Clark/ Cranford/ Fanwood/ Garwood/ Kenilworth/ Plainfield/ Scotch Plains/ Westfield

Somerset County

Bridgewater/ Bound Brook/ Gillette/ Green Brook/ Martinsville/ North Plainfield/ Somerville/ Warren/ Watchung

Middlesex County

Dunellen/ Edison (west of Rt. 27)/ Iselin/ Metuchen/ Middlesex/ Piscataway (north of Lake Nelson-Camp Kilmer)/ South Plainfield

Temporary residence while attending college or medical school does not qualify for this purpose.

- b. Candidates shall be eligible for degrees in medicine from an accredited medical, osteopathic or dental school. Matriculating students in the first through last year can apply.
- c. Candidates shall demonstrate financial need, as determined by the Board of Directors.
- d. Candidates are required to provide the Board with the Graduate Professional School Financial Aid Service (GPFAS) financial statement.
- e. Candidates must be able to attend a personal interview with the Board at Muhlenberg if required.
- f. Candidates must complete and return the application and financial statement forms between January 15 and May 1 of the year in which they wish to be considered for scholarship assistance. Applications received after May 1 will not be considered.
